ONE DAY WORKSHOP ON ASSET LIABILITY MANAGEMENT ON 25TH AND 28TH FEBRUARY, 2011 FOR HOUSING FINANCE COMPANIES REGISTERED WITH NATIONAL HOUSING BANK

The National Housing Bank (NHB) had introduced an Asset Liability Management (ALM) system for the Housing Finance Companies (HFCs), as part of their overall system for effective risk management in their various portfolios, vide Circular NHB(ND)/HFC(DRS-REG)/ALM/1407/2002 dated June 28, 2002. As per the said system HFCs having an asset base of Rs. 100 crores (whether accepting / holding public deposits or not) or holding public deposits of Rs. 20 crores or more (irrespective of their asset size) as per the audited balance sheet as of March 31, 2001 and the HFCs availing refinance assistance from NHB were required to put in place the ALM system. A system of half yearly reporting to NHB was also put in place in this regard.

2. The above guidelines were revised by the National Housing Bank making them applicable to all HFCs irrespective of whether they are accepting / holding public deposits or not.

3. In this context, to familiarise the HFCs with the concept of ALM system and the guidelines issued, NHB is organising a one day non-residential workshop for the benefit of officers of the Housing Finance Companies on 25th and 28th February, 2011 in the Bank's premises at New Delhi.

4. For the purpose of conducting the workshop, the HFCs have been divided into two groups as indicated in the annexure-1. The workshop for first group would be conducted on February 25 and for the second group on February 28, 2001.

5. HFCs are, therefore, requested to depute one officer each on the date indicated in the annexure. The officer shall make his own travel and stay arrangements for the programme and NHB will provide working lunch on the day of the workshop. The nomination form, duly filled, by the officer deputed, should reach "Training Division", National Housing Bank, Core 5A, 5th Floor, India Habitat Centre, Lodhi Road, New Delhi-110 003 latest by February 21, 2011.
