**About National Housing Bank**

The National Housing Bank (NHB) was set up in July 1988, under an Act of the Parliament to operate as a principal agency to promote housing finance institutions both at local and regional levels and to provide financial and other support to such institutions and for matters connected therewith or incidental thereto.

As per the NHB Act, 1987, National Housing Bank is expected, in the public interest, to regulate the housing finance system of the country to its advantage or to prevent the affairs of any housing finance institution being conducted in a manner detrimental to the interest of the depositors or in a manner prejudicial to the interest of the housing finance institutions. The other roles of NHB include financing and promotion.

**Need and Objective of the Programme**

Among the multiple responsibilities entrusted to NHB, the development of human resources is a major agenda of the Bank. Accordingly, the Bank has sought to address this partially through training programmes, seminars and symposia on matters related to housing for the officials of the Housing Finance Companies (HFCs), Commercial Banks and Public Housing Agencies.

The objective of this one day non-residential programme is to create awareness about the importance of housing and housing finance in emerging markets. Further, topics such as regulatory framework of housing finance and other interactive sessions to be held. The programme is aimed at only **women officers** of HFCs and Banks (SCBs, RRBs and UCBs)
