CORRIGENDUM

EOI for Appointment of Tax Consultancy Firm for Assisting and Providing Services in Tax Matters (Both Direct and Indirect Tax)

The Bank in receipts of representations and queries from the many prospective Bidders on the captioned EOI. The Bank has examined the issues involved and decided as follows:

1. Page No.17 - Pre-Qualification Criteria No.1:

Owing to the clause 3.12 of the EOI, sub-contracting for performance of the work, services etc. are not permitted and a company (Public Ltd./Private Ltd.) will not be able to undertake the mandate scope of work such as, *“issuance of certificates to be signed by the CA Firm/LLP Firm”*, without sub-contracting it, as this work will required to be done by the Firm registered with Institute of Chartered Accountants of India (ICAI) as per the provisions of the Chartered Accountant Act, 1949. Accordingly, Private Limited Company or Public Limited Company has been removed from the entities list.

Now, only CA Firm/LLP Firm, registered with Institute of Chartered Accountant of India, can submit their applications.

2. Page No.17 - Pre-Qualification Criteria No.4:

Read the word “and” as “or”. Accordingly, the criteria will be as under:

“The Bidder should have served as tax consultant for at least 2 PSBs/FIs/PSUs/other Government Organizations in India.”

3. Page No.17 - Pre-Qualification Criteria No.5 and Page No.18 - Pre-Qualification Criteria No.6, the word “group company” has been removed.

4. Page No.18 - Pre-Qualification Criteria No.7 & 8, the word “Company” has been replaced with “Firm”.

5. Annexure-I - Bidder Information:

- The word “company” has been removed at Sl. No.1;
- The word “ Type of Company” replaced as “Type of Firm” and the words “Govt./PSU/Pub Ltd/Pvt. Ltd” has been removed at Sl. No.3;
- The word “Company” replaced by “Firm/LLP” at Sl. No.15 & 17;

6. Wherever the word used "seal of the company" replaced by "Stamp of Firm/LLP"
7. Any other changes in the EOI documents due to removal of Company from the entity list for the said EOI will be read suitably by the prospective bidders.
8. The paragraph 10 of the Annexure-VI- Pre Contract Integrity Pact on page No.41 has been omitted/deleted.
9. The following Change are done in the last date of submission of EOI and opening of EOI:
