RTI queries w.r.t. selection of candidates will be entertained only after completion of selection process and declaration of final result of the recruitment*

#### **Instructions for Shortlisted Candidates:**

1. All shortlisted candidates are advised to refer to the interview schedule published on the website for the venues allotted to them and terms and conditions defined therein.
2. Interviews will be conducted through Video Conferencing (VC) at the nearest office of the Bank i.e. NHB Regional Offices/Regional Representative Office/ Head Office on the

scheduled date mentioned in the Interview Call letter. To minimise the travel by candidates amid Covid-19 pandemic, candidates are allotted nearest NHB office as the Interview venue, based on the correspondence address provided in online application form.

3. Candidates are advised to bring all relevant documents in support of their candidature in original and one set of photocopy to the venue of interview for verification purpose.
4. The candidates will not be reimbursed local conveyance cost.
5. In view of COVID-19 pandemic and to ensure safety of the candidates, following must be additionally ensured by the candidates attending interview:
  - a. The interview will be scheduled on virtual platform from the venue assigned to candidates to ensure social distancing and safety
  - b. The candidates must produce their respective RT-PCR COVID-19 test report (not more than 48 hours old as on date of interview), failing which they will not be allowed to enter the interview venue.
  - c. The candidates must show the risk status of "AarogyaSetu App" at the entry point.
  - d. The temperature of the candidates shall also be capture by the Bank.
  - e. Candidates are advised to avoid bringing valuable belongings, friends, relatives, parents etc. to the interview venue.
  - f. The candidates must ensure that they follow all COVID-19 related advisories issued by the Govt. of India and respective State Governments, while attending the interview.
6. Bank will capture the biometric details of the candidates at the venue assigned to them. To facilitate smooth capturing of biometric data, candidates are advised as under:
  - i. If fingers are coated (stamped ink/mehandi/coloured etc.), ensure to thoroughly wash them so that coating is completely removed before the interview.
  - ii. If fingers are dirty or dusty, ensure to wash them and dry them before the finger print (biometric) is captured.
  - iii. Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
  - iv. If the finger (right thumb) to be captured is injured/damaged, immediately notify the concerned authority at the interview venue.
7. Mere issuance of Call Letter to the candidate for Interview phase will not imply that his/her candidature has been finally cleared by the Bank. The Bank will take up verification of eligibility criteria with reference to original documents at the time of Interview. If at that stage, it is found that candidate is not fulfilling the eligibility criteria for the post (age, educational, professional qualification, post-qualification experience etc.), his/her candidature will be cancelled and he/she will not be allowed to appear for Interview. Such candidates are not entitled for reimbursement of any conveyance expenses.
