4. ##### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

##### 2. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

##### 3. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

##### 4. Generic

5. **Service & Support**

Buyer Added text based ATC clauses 1. The bidder must be a limited company or LLPs or Partnership Firm or Proprietorship concern.

2. The bidder must have its office in Kolkata.

3. The bidder must have at least 03 cars (Sedan and Premium Sedan) in its fleet of vehicles including registration of four cars in the name of bidder. The vehicle should be registered as commercial vehicles.

4. The bidder should have valid GST Registration Certificate having valid GSTIN and PAN

5. The bidder must have supplied cars to at least 01 Govt. organization / Public Sector Unit (PSU) during the preceding 02 years.

6. The bidder must have necessary Govt clearance / authority / approval for providing vehicle hiring service.

7. The Agency should not have been blacklisted by any Govt. / Public Sector Undertakings/PSUs/Banks/Financial Institutions in India for providing such services.

8. The successful Bidder will be required to provide performance Bank guarantee/PBG of value amounting to Rs. 20,000, in the form of bank guarantee from a scheduled commercial bank in case they have not pro

vided vehicles along with drivers to any Government Organization/Public Sector Units in the last two years. The PBG, where applicable, should be valid till at least three months beyond the expiry of virtual date of completion of the contract or such other extended period as NHB may decide. The PBG is required to protect the interest of NHB against the risk of non-performance or default in RFP Term/s, including non-compliance of applicable statutory provisions including labour laws and any other laws/rules/regulations, by the successful Bidder. Default in successful implementation of the conditions of the contract, may warrant the invocation of PBG, and also if any act of the Consultant/Bidder results into imposition of Liquidated Damages/penalty, then NHB reserves the right to invoke the Performance Bank Guarantee submitted by such Bidder. The decision of NHB as to non-performance or default in RFP Terms, including non-compliance of applicable statutory provisions etc., shall be final and binding on the successful Bidder.

9. The successful bidder(s) to be called as vendor/agency, shall be required to enter into a Service level Agreement (SLA) with the Bank, within 7 days of the award of the tender or within such extended period as may be specified by the Bank. The service contract may be terminated by giving two months prior notice to the Vendor or the contract may be terminated based on mutual consent in case the services are no longer required.

10. The vehicle and chauffer should be fixed and only in case chauffer goes on leave or car is sent for repair / service, a suitable replacement has to be provided by the vendor.

11. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

a. The Seller fails to comply with any material term of the Contract.

b. The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

c. The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. 6 / 8

d. The Seller becomes bankrupt or goes into liquidation.

e. The Seller makes a general assignment for the benefit of creditors.

f. A receiver is appointed for any substantial property owned by the Seller.

g. The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
