This is in reference of Notification No. S.O 6316 (E) and S.O 6317 (E) dated 26<sup>th</sup> December 2018, with respect to PMAY (Urban) under section 7 of Aadhaar (Targeted Delivery of Financial Services and other Subsidies, Benefits and Services) Act 2016, in respect of four verticals under PMAY (U) viz. AHP, ISSR, BLC and CLSS.

2. In this connection, Ministry in consultation with UIDAI has finalized the format of Aadhaar Consent for PMAY (U) beneficiaries. As per Aadhaar Act, the Aadhaar Consent is mandatory for eligible beneficiaries of PMAY (U). The copy of Aadhaar Consent Format for PMAY (U) is enclosed for reference.
3. In view of above, it is requested to issue the suitable directions to all the PLIs/HFCs to get the Aadhaar Consent as per format enclosed from eligible beneficiaries of CLSS vertical under PMAY (U). It is also requested to maintain log or records of the original copy of Aadhaar consent received from CLSS beneficiaries for future reference ensuring confidentiality of such log or reports.
