

**NATIONAL HOUSING BANK- DEPOSITS SCHEME -Procedure to Claim Unclaimed/
Overdue Deposits**

National Housing Bank had launched two deposit schemes in December, 2008 namely "SUNIDHI Term Deposit scheme "& "SUVRIDHI Tax Saving Term Deposit Scheme with a maturity period ranging from 12 months to 60 months. Some of the depositors have yet not claimed the amount due on maturity of the said fixed deposits.

It may be noted that as per the terms and conditions of issuance of NHB' Deposits, to receive the payment on maturity, investors have to surrender the original Fixed Deposit Receipt, duly discharged by depositor/ depositors along with request form & other necessary documents at any of the following addresses:
